Who are we?

The Kitchen Gallery Sheffield Ltd is a kitchen design, supply & Fitting company that specialises in Kitchens, Supplying and fitting kitchens to all types of premises within the UK.

How do we collect information from you?

We obtain information about you when you use our website, for example, when you complete the contact form, when you complete the site registration form, purchase a product from our store or engage with other forms within our site.

What type of information is collected from you?

The personal information we collect might include your name, address, email address, IP address, and information regarding what pages are accessed and when. If you purchase a product from us, your card information is not held by us, it is collected by our third party payment processors, who specialise in the secure online capture and processing of credit/debit card transactions, as explained below.

Website recording

Like many other websites, the The Kitchen Gallery Sheffield Ltd website uses cookies. How is your information used?

We may use your information to:
